**Sub: Clarification /Confirmation on news item appearing in "Media / Publication"**

This is in connection with the email received from BSE and NSE seeking clarification with respect to (i) media report which appeared in the [www.business-standard.com](http://www.business-standard.com) on November 22, 2024, captioned "*S&P Global revises its outlook on three Adani entities to 'negative'*" ("**Media Report**"); and (ii) decrease in the price of the securities of the Company listed on the Stock Exchanges on November 22, 2024.

In this regard, we hereby submit that as set out in the Media Report, S&P Global has revised its outlook with respect to certain Adani entities, including the subsidiaries of the Company, i.e., Adani Green Energy Ltd Restricted Group 2 Companies. In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI Listing Regulations**"), a listed entity is mandatorily required to make an intimation to the Stock Exchanges for any revision in its rating under Part A of Schedule III with respect to the Company. In terms of the Regulation 30(9) of the SEBI Listing Regulations, the Company is required to make a disclosure of events or information with respect to its subsidiaries which are material for it. Revision in rating of Restricted Group 2 companies, being not material, does not require any disclosure.

Separately, on November 21, 2024, the Company has also submitted its response at 1.38 pm to the clarification sought by the Stock Exchanges on the article appeared on "<https://www.cnbctv18.com/>" dated November 21, 2024,
